NAMASCUSA is currently undergoing some changes. The registrar has been changed. Be sure to mail all club correspondence to the address noted above. Also help your puppy buyers, old and new, by providing them with the new address as well. Below are a few things to remember when submitting registration applications.

- Copies of Championship or Title award certificates are required to use titles in any NAMASCUSA documents.
- Effective with litters whelped on or after June 1, 1998, the following must accompany the litter application or be on file for both the dam and the sire:
 - Copies of OFA Hip Certificates with a rating of fair or better
 - Copies of eyes clear exams or CERF, no more than 15 months old, from a Veterinary Ophthalmologist
- For an individual dog registration the following rules apply:
 - A standard breed Australian Shepherd will not be registered, regardless of size
 - Either it's sire or dam must be a registered NAMASCUSA, MASCA or as a Miniature Australian Shepherd with NSDR
 - Both the sire and dam must be registered purebred dogs, with NAMASCUSA, MASCA, NSDR, ASCA or AKC
 - Copies of registration papers for the dog or it's sire & dam must be submitted, NSDR letters or applications are not accepted
 - A 3 generation pedigree with registration numbers and registered names must also be provided.

Applications will be processed more quickly if you make sure that:

- The form you are using is the latest version, no later than 04/04 (lower right hand corner of the form)
- Forms are completely filled out
- The correct fee is paid (in US dollars)
- That owner and co-owner signatures are obtained everywhere required on the application
- That they are mailed to the Registry Office at the above noted address.
